The Pre Bid **Rs.50,000/-** (Rupees Fifty Thousand only) **by RTGS/NEFT** should be deposited by intending registered bidders with Egbert Andrews Auction Mart, 161 Lenin Sarani, Kolkata-13 **on or before 21<sup>st</sup> July 2025 upto 4 PM after which pre bid amount will not be accepted.** The Pre bid amount in respect of unsuccessful bidders will be returned after completion of the online e-auction.

1. **EARNEST MONEY: 20%** of the sale value of the accepted bid/bids kept open for acceptance should be paid by the successful purchaser **online by RTGS/NEFT** as earnest money to the auctioneer within 7 (Seven) days from the date of confirmation by auctioneer on completion of online e-auction. Failure to deposit the 20% earnest money within scheduled time registration cancellation/debarring for at least 6 months & forfeiture action will be taken against the back out bidder by auctioneer.
2. The entire balance of sale value shall be paid online **by RTGS/NEFT to the auctioneer** within 17 (Seventeen) days from the date of completion of online auction **SOLD** lots and within 10 (TEN) days from the date of issue of acceptance letter from the auctioneer **EGBERT ANDREWS AUCTION MART** for STA lots. If the buyer fails to make payment for the balance sale value by the stipulated date the period for such payment may be extended by the auctioneer **EGBERT ANDREWS AUCTION MART** / Stockholder or his representative at their discretion on payment of @1% per week or part thereof on the sale value default, to a maximum period of two (2) weeks only.
