GENERAL TERMS & CONDITIONS OF SALES BY AUCTION

Payment for material lifting will be deposited in TML account in one day advance, the fund deposited before 3.30 PM in the same day of lifting will only be treated for making invoices.

1. DISPOSAL

- 1.1. The General condition of the goods against all lots of the catalogue shall be treated as Scrap, rejected, write-off materials, obsolete and condemned unless otherwise specifically mentioned against the items or lots. The Company shall not be liable for or be bound in any manner for any representation or statements which are not contained in the general conditions of sale and/or catalogue or are contrary to or inconsistent there with purported to be made by the auctioneers, if any and/or officer of the Company.
- 1.2. Numbers, quantities or tonnage or nature of materials given in the catalogue are mere approximations and the materials will be sold without any regard or consideration of these numbers / tonnage or nature of materials and no warranty or guarantee shall be implied. Goods will be sold on 'as is where is basis'. No segregation will be allowed

1.3 Lifting Period : mentioned with part list

- 1.4. Where materials are sold on arising basis the arising provide only an index for the amount of deposit which is required to be cleared by the Buyers. But as the paramount interest of the Compa-ny is to get the area cleared of all accumulated scrap, the Buyer will have to remove the entire arising (stock plus in-coming) if Company desires so, even though such actual arising may travel far beyond the limit of approx-imation indicated. The decision of Company in this regard shall be final.
- 1.4 a. The total quantity of the materials to be sold may be indicative/approximate and shall be subject to availability. In the event that the total quantity of materials to be lifted is less than stipulated, the excess EMD deposited shall be refunded to the buyer on successful completion of contract or ground clear of lot. It is expressly declared that no interest shall be paid to buyer on the excess EMD.
- 1.5. The Company shall be under no obligation to put up the lots singly or serially or any other manner and the company reserves the right at its discretion to withdraw any lot at any time during the period of auction/tender without assigning any reason thereof.
- 1.6. The Company reserves the right to remove such materials from the lot(s) which it finds; it does not belong to the lot(s) auctioned.
- 1.7. The Company's representatives supervising the auction will have authority to amend the unit of quantity of any lot.

2. PARTICIPATION/REGISTRATION

- 2.1. The employee of the company shall not be allowed to participate in the **SCRAP** auction.
- 2.2. All rights of admission to allow participation in the auction is strictly reserved with the Company without assigning any reason thereof.
- 2.3 Participants will be allowed if and only if they have declared in writing on that they have gone through the terms and conditions and are acceptable to them. They must be INCOME TAX PAYER with valid PAN and SALES TAX PAYER with valid REGISTRATION NO. and must enclose BANK CLEARANCE CERTIFICATE along with photo copies. They must bring originals of Income-Tax return and GST registration certificate along with photo copies for verification. The photo copies along with declaration will be retained by the management after tally/verification

3. INSPECTION OF SCRAP MATERIALS

- 3.1. Entry of buyer or their authorized representative into Scrap Yard will be only for supervision of the materials as per schedule given in the catalogue.
- 3.2. The intending parties shall be allowed to inspect the goods advertised for sale prior to the auction by arrangements through auctioneers or the department concerned of TATA MOTORS LIMITED. Admission to Works will be by express permit that will be issued on request. Name of firms and/or their representatives intending to visit the works should be specified in the registration form.

4. OFFER BID

- 4.1. All lots will be sold to the parties with highest offer subject to the reserve price fixed by the Company. In the event of dispute or two or more parties, the lot in question may be put up again and at the last undisputed offer made will be considered for approval for the lot.
- 4.2. No offer once made by the party can be withdrawn by him irrespective of whether the Company accepts it as firm or subject to approval.
- 4.3. The Company may refuse to accept any offer from any person without assigning any reason for such refusal. The Company also reserves the right to sell on Firm or subject to approval (STA) basis.
- 4.4. The Company reserves the right to accept or reject any offer or to add/delete any lot without assigning any reason. In case of any dispute the decision of Plant Head, Lucknow Works will be final and binding.

5. EARNEST MONEY

5.1. Pre bid amount to be deposited by bidders in the bank account of **Egbert Andrews Auction Mart Auctioneers**. The successful bidders will have to deposit **in the form of / RTGS / NEFT issued in the favour of "TATA MOTORS LIMITED"**, **payable at Lucknow**, which will be adjusted/refunded only on successful completion of sale order.

5.3 The Company's representatives supervising the auction will have authority to amend the requirements of earnest money deposits.

6. APPROVAL OF RATES

6.1. All the offers received during auction will be subject to the approval of Company.

7. RELEASE OF SALE ORDER

7.1. The Sale Orders will be released immediately after approval.

8. PAYMENTS

- 8.1. Balance amount (balance amount = total cost EMD) i.e. rest of the total cost of sold scrap material will have to be deposited by demand draft in favour of **M/S. TATA MOTORS LIMITED** before lifting of lot(s). Failing which will result ipso-facto termination of the contract, and the above deposits (**EARNEST MONEY**) will be forfeited, and the bid shall stand cancelled. The material in question shall be treated as 'not sold'. It is the responsibility of the Buyer to keep checking with **SCRAP DISPOSAL** Department for approval and sale order.
- 8.2 The Company's weigh bridge/weighing scale or counting as the case may be will be treated as final for payment.
- 8.3 The buyers will have to ensure the payment of full cost after depositing the difference amount other than EMD with taxes etc. before lifting of any lot(s) on lot to lot basis in case of one time lot and will have to remove the entire sold lot. On non-confirmation of this clause the penalties mentioned herein and as deemed fit by the Company on case to case basis shall be levied. In case of arising lot, after first ground clearance, the buyer will have to pay total money for the subsequent quantity available. This will be repeated till the expiry of sale order.
- 8.4 Purchase money plus taxes must be deposited by the Buyer with the Company in advance through bank draft/RTGS/NEFT in the office hours. After such payment of the entire purchase money including all Taxes and Duties the Buyer will be entitled to remove the goods from the site of the Company as per the Schedule and delivery order given by the Executive Officer (Tata Motors Limited), or his representative.'
- All buyers who are interested to pay through RTGS and NEFT need to make RTGS/NEFT payment lot wise. While filling up the details of TML in Bank format buyer should ensure correctness of information provided by TML. In case the payment is not deposited in TML account by the specified date due to incorrect data provided by the buyer penalty as per terms of auction will be payable by buyer. After completion of formalities for transfer of fund buyer will intimate through e mail to Finance and disposal section UTR number (provided by bank), Buyer Name, Buyer Code, Lot Number, Amount and Name of Bank and branch from where fund has been transferred. TML will credit the amount only in the next day of RTGS information receipt through e-mail. Receipt of e-mail is valid from 8.30 AM to 4.00PM on all working days of TML. If mail received after 4.00 PM, this will be considered as received on next working day. Credit will be given to buyers account after verification of TML Passbook. RTGS/NEFT fund transfer should be made one day before from last payment date mentioned in sale letter. No RTGS/NEFT fund transfer is accepted against caution money/EMD deposit.

9. TAXES, DUTIES, CERTIFICATES ETC.

- 9.1. The Buyer should furnish copies of his GST Certificate failing which there will be delay in issue of the Delivery Order. No delivery order will be issued on account of a Buyer who is not registered dealer under the GST Act, till he submits his GST declaration form wherever applicable.
- 9.2 All the Taxes,TCS and all other taxes, duties (imposed) whether payable to the Central Government or the State Government or to the Municipal, local or other authorities shall be deposited by the Buyer with the Company along with the purchase money as part of the purchased price, Non-payment of any amount payable under this clause will have the same effect as non-payment of the purchase money and will result in ipso-facto termination of the contract and forfeiture of security and earnest money. All the Taxes,TCS and all other applicable taxes will be charged extra and mentioned in the catalogue. However the actual taxes and duties as applicable at different location and at the time of lifting & billing will be applicable. If the liability, of such tax (imposed) and/or duty is in doubt, the Company will have a right to call upon the Buyer to make such provision as the Company may deem fit and proper to ensure recovery of such taxes (imposed and/or duty). If the tax (imposed) and/or duty is not recov-

ered at the time of delivery/dispatch the Company will have the right to call upon the Buyer, to pay such amounts as may be due. If the Company finds that it has omitted to charges or the Company becomes liable to pay higher charge as a result of decisions or announcements by Government or any other competent authority, even after, the full value of the materials may have been deposited and lifting completed from the Company's works. The Company shall be free to call upon the Buyer to make good the amount short recovered. Whenever such contingency arises, the Company shall be entitled to recover the amount of such Tax (imposed) or duty from the Buyer or set off against any amount or amounts that might at any time become payable by the Company to the Buyer on account whatsoever.

10. LIFTING OF SCRAPS

- 10.1. The lifting of scrap as per stipulated time and quantity is the essence of this Contract. The work undertaken will be carried out only by the workers or the agents engaged by the Buyer as approved by the Company. The Buyer shall be allowed the cutting of the materials if required on case to case basis that work shall be carried out by the party / Buyer himself, no any support /facilitation shall be granted by the TML. If any sold material is mixed with other material which is not sold then the Buyer may remove of detached the not sold materials on its own with the concurrence of Company.
- Buyers must lift the items purchased by him on all six working days of week and must lift the 100% of lot or ground cleared on or before the last date of lifting. Failing which the suitable penalty and action as prescribed shall be levied.
- 10.3 The lifting periods indicated is inclusive of holidays and Sundays. No extra time will be allowed on this account. If there is holiday on the last date of lifting then next working day may be considered Last Lifting Date however, the decision of Company in this regards shall be final.
- 10.4 Lots sold must be cleared within the stipulated period to the extent of materials available, partial lifting will not be permitted and will be subjected to penalty. If materials are scattered and need to be collected, it will be responsibility of buyer to get all such materials collected and loaded into their vehicle under their own arrangement.
- 10.5 From the time of sale, unit removal, the goods shall remain in the premises of the company at the risk of the Buyer.
- The Buyer will make their own complete arrangements for removal of the materials. The offer for the goods sold, shall be deemed to have taken into account and made due allowance for the cost of handling (including separating the scrap materials into convenient lots permitted by the company) loading or other expenses (including dismantling where permitted by the company) for purpose of offer for different lots of goods and their removal, and shall be entirely responsible for booking the goods by rail where so required. The Company will affect deliver of goods only at the site or at a convenient location which will be notified at the time of sale.
- Buyers **MUST** make their own assessment of various aspects of lifting requirements and start lifting only after organizing their capabilities on inspection of the lot. Company will not be responsible for their miss-assessment of shortcomings. No segregation shall be allowed from any of the material. The Buyer must make in to his mind the position, condition and mixing if any in the Lot / Material at the time of inspection and then only after this only they should bid. The Company may arrange the presentation of photos of scrap materials at the time of Auction, however all the Buyers should bid on the basis of inspection made by them and should not bid only on the basis of names or photo of materials. In case of any dispute of conditions, positions or otherwise between the actual inspections/position and photos presentation then the actual inspection shall prevail. Lifting will have to be completed within the period as per stipulations. Company may demand to lift the materials within or before stipulated time frame given. Delivery hrs: 8-30 A.M. to 5 P.M. Monday to Saturdays. No delivery on off days. The Buyer shall be allowed to start lifting the material from the location decided and directed by Tata Motors Ltd. (in case the same material is lying on different locations of the plant whether already specified in the catalogue or not).
- At the time of obtaining delivery of any goods, the Buyer shall not be entitled to pick or choose any particular item or items from the lots sold to Buyer. The Buyer will have to operate the lot from one side of the heap until the entire quantity is lifted. The party at any point of time must lift the whole lot or the minimum quantity/trip as mentioned/advised. The weight of the weighing machine of Tata Motors Ltd. shall be the final and should not be questioned and compared from any outside weighing machine at any point of time.
- Wherever crane is required for loading it will be the responsibility of buyer to arrange crane and ensure that the materials is lifted within the stipulated period as mentioned in sale letter.
- In case Buyer requires any service or facility from the Company for dismantling loading and removing the goods, the Company may without being under any obligation may provide the same at cost basis. The Buyer must deposit in advance with the Company such amount as may be required by the Company on this account. All expenses for such service will be recovered from the amount so deposited and the surplus, if any, would be refunded to the Buyer. The amount so deposited will not carry any interest. In case the amounts deposited falls short of the charges payable under this clause, the Buyer shall immediately on requisition by the Company pay the additional amount. Crane hire-charges where provided will be applicable in terms of one hour and its multiplies and not in terms of a fraction of one hour.
- 10.11 The Buyer shall not be entitled to re-sell any lot or part of a lot while the goods are still lying within the premises of the company and no delivery would be effected by the company to any person or entity other than the Buyer whose as names are mentioned in the delivery order. Change of buyer's name and address will not be allowed after finalization of sale.
- 10.12 The terms & conditions and mode of disposal may be modified at any point of time on the sole discretion of the management.
- 10.13 If the scrap loaded vehicle remain hold due to any problem / fault either invoicing delay or any other problem in side the plant for overnight then the reweighment of the vehicle shall be done at the time of moving out of the vehicle. And if the difference of the weights beyond permissible limits found then whole vehicle may be unloaded and reloaded in the presence of security.

11. PENALTY

11.1 The forfeiture of balance quantity / percentage of total **EARNEST** money will be done as mentioned below. To compute the forfeiture of EMD the percentage of total lifting quantity against total declared / sold quantity shall be considered.

EMD will be adjusted / Released only on the payment of Final loading of the lot. No EMD will be released before final loading.

- 11.2 If the buyer fails to lift his materials within the stipulated period and as per prescribed frequency and schedule, an additional penalty will be at 3% of base value of material for first 7 working days after last lifting day and at 7% of base value of material lifted between 7 days after last lifting date to 15 days, till successful completion of sale order, shall be levied on the buyer and shall be adjusted from the EMD, provided that the buyer shall on or before the due date for lifting the materials, raise a request with the Company for such extension to lift the materials and the Company may at its sole discretion allow such extension. Notwithstanding anything mentioned previously in this sub- clause, the Company reserves the absolute right to decide the quantity of materials to be lifted by the buyer, to limit/specify the extended period, if granted, within which the materials needs to be lifted and to specify the penalty amount once the stipulated period is over. Such decision of the Company shall be final and binding on the buyer.
- Buyers must lift the scrap items as per para 11.4 mentioned herein. In case of material sold on arising basis, the Buyer will have to remove the entire arising on daily basis / regularly on arising of material and ground clearance will have to be done up to the satisfaction of Admin Department as per terms and conditions read with additional terms and conditions (if any). Failing which will called the non-conformities and the penalty as deemed fit by the Company or as per terms & conditions shall be levied on daily / per occurrence basis and if non conformities occurs for more then two times then the contract of sale / lifting can be terminated and the deposits as EMD etc. can also be forfeited.
- 11.4 In case the party fails to deposit balance money within stipulated time and or fails to lift materials after depositing money within and as per the time given herein, the sale order will be treated as cancelled forfeiting the earnest money deposited without any prior notice.
- 11.5 Penalty imposed will be based on cost of material (Excluding taxes, duties and loading charges). And each lot shall be treated as a separate case.
- In the event of default and/or failure on the part of the Buyer to remove the goods after payment of the entire purchase money within the stipulated time mentioned above, his entire deposits EMD etc. shall be forfeited and the Company may acted as the Agent of the Buyer will be entitled to sell the goods by public auction/tender at such prices as the Company may in its absolute discretion think fit. If it is detected at any time that the customer had loaded a material or materials for which he is not the auction Buyer and the lot / materials lifted by violating terms & conditions, Lifting after segregation which is not allowed and if the persons of lifter found indulging in any in disciplinary activity, the Company will be within its right to take such action and penalty as forfeiting of security deposits or other deposits or both and/or can also make the claim of loss / damage. The sale proceeds thereof will be credited to the account of the Buyer for any claim for sale of the goods at a lower price than the market price and in this respect the Buyer shall be deemed to have appointed the Company as its agent.
- 11.7 Buyer are cautioned that attempt to misuse Gate Pass, Challans authorizing delivery or any such documents will open them to serious penalties or such other action as may be open to the Company. The Buyers should, therefore, ensure that important documents relating to sale are in the custody of trust worthy and responsible persons.
- 11.8 In case of default of deposit within the allowed period, the contract of sale between the Buyer and the Company shall Ipso-fact terminated and the security and earnest money deposited by the Buyer stand forfeited by the Company. The Company shall not be bound to give any notice to the Buyer of the cancellation of the contract of or the forfeiture of the earnest money. Further the Company shall be free to sale / disposed of the material / Lot in question.
- 11.9 Notwithstanding anything to the contrary contained in various clauses the Company may at any time on the application of the Buyer annul the forfeiture / penalties and permit the Buyer to pay the purchase money with or without such additional amount and within such period and on such terms and conditions as the Company may at its absolute discretion thinks fit.
- 11.10 The Buyer shall ensure that as and when the Security Money / Entry Fee / EMD etc. or any part thereof is adjusted by the company against any penalty for breach of any terms & condition of this Contract, non conformities or otherwise, the amount of deposit from time to time is to be replenished to its original limit

12. COMPLETION OF SALE ORDER

12.1 A sale order is treated as complete only when the party has lifted the entire mentioned lot successfully within the stipulated period depositing all dues.

13. LEGAL

- 13.1 All complaints or applications / requisitions of whatsoever nature may be referred to the Head (security & Admin), Tata Motors Limited, Lucknow, by the parties concerned.
- Buyers would be required to follow all safety rules and regulations of the company requirements in this regard have been laid down, for any clarification buyers may contact safety department. Buyers will be allowed to start removal of materials only when they have confirmed in writing that they would like to follow the specified guidelines while on this it may be noted that as

per provision of Factories Act/Rules Company is required to submit report to the Inspector of Factories for all accident inside the Works immediately.

- 13.3 The buyers should ensure that the vehicles which are being placed for lifting should have all valid and required documents such as RC, DL of Driver, Issuance, Fitness, Road permit etc. as per Central Motor Vehicles Act, and Rules as applicable in all over India along with specific rules applicable in UP if any. This is also to be ensured by the Buyers that the vehicles should be physical fit and all the required parameters like Head lights, Tale lights, Bilkers, Side Blinkers, Horn, Brakes, Hand Breaks, side mirrors, Back mirrors etc. should be proper and in working conditions. Failing which the vehicles shall not be allowed in side plant.
- Any violation of safety norms by the buyers or his employee, workmen, representative will attract penalty and the amount of penalty decided by the company will be final. Buyers must forthwith deposit this amount before continuing with any activity relating to particular lot including removal / lifting.
