#### TATA MOTORS LIMITED

#### Safety guidelines for Scrap Customer

- 1) The buyer shall adhere to all safety, environmental, and site protocols as prescribed by TML.
- 2) Fitness certificate of the vehicle for scrap lifting is mandatory for entry into TML.
- 3) The driver must have a valid driving license and be in good health and mental condition. Drivers and helpers coming inside plant must have the safety shoe of good condition.
- 4) The driver has to drive within the TML specified speed limit (not exceed 16 Km/Hr).
- 5) Drivers and helpers must not be engaged in any activity during loading except appropriate vehicle parking and stay away in safe distance from any loading unloading activity including any representative of buyer.
- 6) After parking the vehicle at the loading point or parking area, the wheel chocks will be placed diagonally. The wheel chock will be placed on the front right wheel from the front side and on the rear left wheel from the rear side.
- 7) While reversing the vehicle, the vehicle must have a reverse horn and there must be a co-driver or another person to give instructions to the driver from behind.

- 8) Before loading, the driver will have to handover the ignition keys to the security guard.
- 9) Before starting the vehicle, the driver will check under and around the vehicle and only when everything is normal will he start the vehicle and take it slowly.
- 10) All loading workers will use the required full PPE'S. It is mandatory to wear helmet with strap. Do not work wearing torn or cut safety shoes. Work only wearing hand gloves. It is mandatory to wear leather gloves and arm sleeves for sheet metal loading.
- 11) Ladders will be used as necessary for climbing and descending.
- 12) The locking device has to be locked properly to keep the ladder stable.
- 13) Do not use a ladder if it is unfit for use in any way, such as broken steps, broken structure, locking device not working, etc.
- 14) Loaders have to work only in the place marked for them, they should not go here and there.
- 15) Lifting/loading of scrap material above the truck's body height and in tail gate open condition will not be allowed for any kind of scrap material.
- 16) In case of ill health or any other injury, the loading work will not be done and the same will be reported to the TML officer.
- 17) No person / labour with medical problems of chronic nature viz; epilepsy, impaired eyesight / hearing, sick persons etc., shall be brought by the contractor seeking entry into TML premises.
- 18) Any kind of loading work in low illumination is not allowed.
- 19) Before starting the loading work, ensure that the housekeeping of the loading point is proper and after loading, leave the work site only after doing the housekeeping of the loading point.
- 20) Loading work will not be done during rain and strong winds and the loading employee will have to go to the designated safe place.
- 21) Any damage to TML property during lifting or transport will be assessed and charged to the buyer.
- 22) **Transport Arrangement:** The arrangement of trucks and trailers will be the sole responsibility of the scrap buyer.
  - The size and type of transport vehicle must match the dimensions of the dismantled machinery to ensure safe and efficient movement.
  - Good and safe vehicle condition will only be allowed including all the relevant documents like registration, fitness, license, PUC etc.
  - Any delay due to inappropriate vehicle arrangement will be considered a default by the buyer
  - Tata motors being a Tobacco free organization, the truck driver and helpers must strictly abide to this rule.
  - Truck / trailers must be equipped with wheel choke and vehicles must be parked in the designated place only.

#### **GENERAL TERMS & CONDITIONS OF SALES BY AUCTION**

#### 1. DISPOSAL

- 1.1. The General condition of the goods against all lots of the catalogue shall be treated as Scrap, rejected, obsolete and condemned unless otherwise specifically mentioned against the items or lots. The Company shall not be liable for or be bound in any manner for any representation or statements which are not contained in the general conditions of sale and/or catalogue or are contrary to or inconsistent there with purported to be made by the auctioneers, if any and/or officer of the Company.
- 1.2. Numbers, quantities or tonnage nature of materials given in the catalogue are mere approximations and the materials will be sold without any regard or consideration to these numbers / tonnages or nature of materials and no warranty or guarantee shall be implied. The quantity of arising / arranged lot may vary considerably i.e. they may be much more or much less than the approximation indicated in the list.
- 1.3. Goods will be sold on, as is where basis is. Bids will be deemed to have been made on the clear understanding that intending bidders have satisfied themselves fully in regards to the nature, condition, quantity, quality of goods upon inspection or otherwise. No error, omission or misstatement of misdescription whatsoever and howsoever made or published whether in the catalogue or otherwise and no defects or faults in the goods shall annul the sale or be the subject of any claim on the part of the purchaser whether by way of compensation or otherwise howsoever nor will any such claim be entertained by the Company.

- 1.6 The Company's representatives supervising the auction will have authority to amend the unit of quantity of any lot.
- 1.7 If any metal, not covered explicitly in the description of the lot, is found in any of the lots while effecting delivery, the same shall be treated as Company's property. The Purchaser shall not lift from the lots any such materials and shall have no claim to the same or ask for any compensation on account thereof. If it is detected at any time that the customer had loaded a material or materials for which he is not the auction purchaser, the Company will be within its right to detain the truck unload the materials at cost and expenses of the customer and take such other and further action as may deem fit and necessary for the purpose.
- 1.8 Capital items (surplus/obsolete machinery) will be delivered from surplus machinery stores only.
- 1.9 Capital items (scraps other than machinery) will be delivered from scrap yard only.
- 1.10 If the successful purchaser at any stage either neglects or refuses or is unable to take complete delivery of the material for any reason whatsoever / or the performance of the purchaser is unsatisfactory, the company will have the right to terminate the contract and forfeit his EMD / S.D. amount and claim such further losses and damages that may be caused to the company by such breach. Whether successful purchaser's work is satisfactory or not, will be for the company to determine and declare at its sole discretion. Upon termination of contract the purchaser will be immediately seized for the set duration of sale period and enquiry will be conducted by the TML Officers or through its Internal / External representatives for fair enquiry. - 1.11 The circumstances foreseen in the preceding para shall remain subject to the final discretion and subjective satisfaction of the Plant Head, TML Pantnagar keeping in view the facts and circumstances of the case in its entirety.

#### 2. PARTICIPATION/REGISTRATION

- 2.1. The employee of the company shall not be allowed to participate in the SCRAP auction.
- 2.2. All rights of admission to allow participation in the auction is strictly reserved with the Company without assigning any reason thereof.
- 2.3. Participants will be allowed if and only if they have declared in writing on REGISTRATION FORM (ANNEXURE-I) that they have gone through the terms and conditions and are acceptable to them. They must be INCOME TAX PAYER with valid PAN and SALES TAX PAYER with valid REGISTRATION NO. and must enclose BANK CLEARANCE CERTIFICATE along with photo copies. They must bring originals of Income-Tax return and Sales Tax registration certificate along with photo copies for verification. The photo copies along with declaration will be retained by the management after tally/verification. The purchaser should also furnish copies of his 'GSTIN' Registration certificate for updating master data. No business would be possible in absence of 'GSTIN'. All the bidders are to carry original AADHAR / PAN cards. Authorization letter in the letterhead must be carried by the vendor's representative, before the physical Auction starts.
- 2.4. The selection/rejection of parties/rates depends at the sole discretion of the management without assigning any reason thereof.

#### 3. <u>INSPECTION OF SCRAP MATERIALS</u>

- 3.1. Entry of buyer or their authorized representative into Scrap Yard will be only for supervision of the materials as per schedule given in the catalogue.
- 3.2. The intending parties shall be allowed to inspect the goods advertised for sale prior to the auction by arrangements through auctioneers or the department concerned of TATA MOTORS LIMITED. Admission to Works will be by express permit that will be issued on request. Name of firms and/or their representatives intending to visit the works should be specified in the registration form.
- 3.3. Buyers or their authorized representative are not allowed in Kurta-Paizama and Slippers in the Tata Motors premises. Everyone must come for inspection of the scrap lot wearing safety shoes and safety helmet.

#### 4. ENTRY IN AUCTION HALL

4.1. Only one person will be allowed from each firm/trader/organization against entry permit issued after depositing PAN CARD/REGISTRATION FORM and Pre Bid EMD.

4.2. All participants will have to deposit in advance Pre-Bid EMD INR 2,00,000/- (Rupees two lacks only) with Auctioneer **EGBERT ANDREWS AUCTION MART** through RTGS. #### 5. OFFER BID

- 6.3 The Company's representatives supervising the auction will have authority to amend the requirements of earnest money deposits.
- 6.4 Acceptance or rejection of STA bid will be communicated within 30 days from the last date of auction. In case of rejection earnest money will be refunded without any interest.

#### 9. PAYMENTS

- 9.1. The Company's weigh bridge/weighing scale will be treated as final for payment.
- 9.2. The buyers will have to pay the full cost of materials plus taxes etc. before lifting the materials and will have to remove the entire lot, irrespective of whatsoever weight mentioned in the sale order. This is true in both the cases i.e. ONE TIME BASIS and ON ARISING BASIS.
  - In case of arising basis, after first ground clearance, the buyer will have to pay total money for the subsequent quantity available. This will be repeated till the expiry of sale order.
- 9.3. Purchase money plus taxes (GST) must be deposited by the purchaser with the Company in advance through bank draft/RTGE/NEFT between 9:00 a.m. to 1:00 p.m. and from 1-30 p.m. to 4-00 p.m. After such payment of the entire purchase money including all Taxes and Duties(GST) the purchaser will be entitled to remove the goods from the site of the Company as per the Schedule and delivery order given by the Executive Officer (Tata Motors Limited), or his representative.
- 9.4. As per GST laws "Advances" are subject to GST.
- 9.5. If the date of payment falls on any off day, payments will be accepted on following working day.(BEFORE EXPIRY OF THE TIME LIMIT).

#### 10. TAXES, DUTIES, CERTIFICATES ETC

- 10.1. The purchaser should furnish copies of his 'GSTIN' Registration certificate for updating master data. No business would be possible in absence of 'GSTIN'.
- 10.2. All GST (imposed) whether payable to the Central Government or the State Government or the Union Territory or to the Municipal, local or other authorities shall be deposited by the purchaser with the Company along with the purchase money as part of the purchased price, Non-payment of any amount payable under this clause will have the same effect as non-payment of the purchase money and will result in ipso-facto termination of the contract and forfeiture of security and earnest money. If the liability, of such tax (imposed) and/or duty is in doubt, the Company will have a right to call upon the purchaser to make such provision as the Company may deem fit and proper to ensure recovery of such taxes(imposed and/or duty). If the tax (imposed) and/or duty is not recovered at the time of delivery/dispatch the Company will have the right to call upon the purchaser, to pay such amounts as may be due. If the Company finds that it has omitted to charges or the Company becomes liable to pay higher charge as a result of decisions or announcements by Government or any other competent authority, even after, the full value of the materials may have been deposited and lifting completed from the Company's works. The Company shall be free to call upon the purchaser to make good the amount short recovered. Whenever such contingency arises, the Company shall be entitled to recover the amount of such Tax (imposed) or duty from the purchaser or set off against any amount or amounts that might at any time become payable by the Company to the purchaser on account whatsoever
- 10.3. All applicable taxes, duties, and levies shall be borne by the buyer.

#### .11. LIFTING OF SCRAPS

- 11.1. Work undertaken will be carried out only by their workers or the agents engaged by them as approved by the Company. Buyers must make their own assessment of various aspects of lifting requirements and start lifting only after organizing their capabilities on inspection of the lot give their bid. Company will not be responsible for their misassessment or shortcomings/mistakes. Lifting will have to be completed within the period as per stipulations.
- 11.2. The purchaser will make their own complete arrangements for removal of the materials. The offer for the goods sold, shall be deemed to have taken into account and made due allowance for the cost of handling (including separating the scrap materials into convenient lots of permitted by the company) loading or other expenses (including dismantling where permitted by the company) for purpose of offer for different lots of goods and their removal, and shall be entirely responsible for booking the goods by rail where so required. The Company will effect deliver of goods only at the site or at a convenient location which will be notified at the time of sale.
- 11.3. After paying the entire purchase money for lot as per the terms & conditions detailed elsewhere the purchaser will submit a written request to the company for necessary entry permits for the purchaser's labours and technicians. Such written request shall be in the format prescribed by the company available at scrap yard. If purchaser intends to bring in any of his equipment's to facilitate dismantling for removal of the goods, such equipment's must be specifically mentioned in the written request. On receipt of a written request from the purchaser with all necessary particulars, the Company at its discretion may permit entry of purchaser's technicians, equipment etc. The purchaser shall be wholly liable for and shall duly make goods any damage or loss to any property of the Company caused by the purchaser or any member of his staff or any agents, employees, clerk, workman or servant. The Company shall not be held liable under any legislation relating to factories or Workmen's Compensation Act or otherwise for any breach of law or injury to the purchaser or any such person aforesaid, while working within TATA MOTORS LIMITED premises.

- 11.4. Buyers MUST make their own assessment of various aspects of lifting requirements and start lifting only after organizing their capabilities on inspection of the lot. Company will not be responsible for their missassessment of shortcomings. Lifting will have to be completed within the period as per stipulations.
  - Lifting Hrs: 8-30 A.M. to 3-30 P.M. Monday to Saturdays. No delivery on off days.
- 11.5 At the time of obtaining lifting of any goods, the purchaser shall not be entitled to pick or choose any particular item or items from the lots sold to purchaser. The purchaser will have to operate the lot from one side of the heap until the entire quantity is lifted. The party at any point of time must lift the whole lot or the minimum quantity/trip as mentioned/advised.
- 11.6 Wherever crane is required for loading it will be the responsibility of purchaser to arrange crane and ensure that the materials is lifted within the stipulated period as mentioned in sale letter.
- 11.7 The lifting periods indicated is inclusive of holidays and Sundays. No extra time will be allowed on this account.
- 11.8 Lots sold must be cleared within the stipulated period to the extent of materials available, partial lifting will not be permitted and will be subjected to penalty. If materials are scattered and need to be collected, it will be responsibility of buyer to get all such materials collected and loaded into their vehicle under their own arrangement.
- 11.9. All lifters must contact Company's authorized officer to get themselves fully acquainted with safety rules and regulations. Lifters will be allowed to start collecting materials only when they have confirmed in writing that they are agreeable to follow the various safety rules and plants regulations. This is necessary because as per provision of U.K. Factories Act/Rules the company's Works are required to submit reports to the Inspector of Factories for all accidents inside the Works immediately.
- 11.10 Transport Contractor inside Tata Motors Limited, Pantnagar works may be screened by the company.
- 11.11 In case dismantling of machines/assets is required for removal or lifting, it shall be carried out only by TML-registered business partners. The Company may without being under any obligation may provide the same at cost basis. The purchaser must deposit in advance with the Company such amount as may be required by the Company on this account. All expenses for such service will be recovered from the amount so deposited and the surplus, if any, would be refunded to the purchaser. The amount so deposited will not carry any interest.
  - In case the amounts deposited falls short of the charges payable under this clause, the purchaser shall immediately on requisition by the Company pay the additional amount. Crane hire-charges where provided will be applicable in terms of one hour and its multiplies and not in terms of a fraction of one hour.
- 11.12 From the time of sale, unit removal, the goods shall remain in the premises of the company at the risk of the purchaser.
- 11.13 The purchaser shall not be entitled to re-sell any lot or part of a lot while the goods are still lying within the premises of the company and no delivery would be effected by the company to any person or entity other than the purchaser who's as names are mentioned in the delivery order. Change of buyer's name and address will not be allowed after finalization of sale.
- 11.14 The terms & conditions and mode of disposal may be modified at the sole discretion of the management.
- 11.15 The company reserves the right to permit the lifting of scrap during the period of work suspension if any.
- 11.16 Tractor trolley is not allowed inside TML Pantnagar plant for lifting scrap except in wooden lot.

#### 12. <u>PENALTY</u>

- 12.1 If any purchaser found doing mischief, forming pool, or creating disturbance in the hall will be asked to leave the hall immediately forfeiting his ENTRY/SECURITY/EARNEST MONEY. In this case, the rate offered will not be accepted and his name will be delisted from all future participation.
- 12.2 If any successful purchaser or any of his employee or his representative commits any act which amounts to an offence committed against person or property mentioned in the Indian Penal Code 1860, or commits any other act which amounts to an offense under the said Code or any other criminal law for the time being in force in India against TML, then a show cause notice shall be issued to the purchaser requiring him to show cause within 10 days from the date of receipt of the notice, as to why the contract of sale should not be terminated. Failure to show cause within the requisite period or not able to justify his/her case, the contract of sale between the purchaser and the Company shall stand terminated and entry fees of Rs 25000/- will be forfeited as bare minimum penalty or as decided by the Plant Head, TML Pantnagar on the recommendation of TML SDC (Scrap Disposal Committee). Further, the contractor will be debarred from taking part in the subsequent auction to be held for Scrap Disposal and simultaneously the appropriate criminal proceedings may be initiated at the discretion of the Plant Head, TML Pantnagar.

- 12.3 In case the party fails to deposit balance money and or fails to lift materials after depositing money within 14 working days from the date of sale order, the sale order will be treated as cancelled forfeiting all entry/security/earnest money deposited without any prior notice.
- 12.4 Penalty imposed will be based on cost of material (Excluding taxes, duties and loading charges).
- 12.5 In the event of default and/or failure on the part of the purchaser to remove the goods after payment of the entire purchase money within the stipulated time mentioned above, the Company as the Agent of the purchaser will be entitled to sell the goods by public auction/tender at such prices as the Company may in its absolute discretion think fit. The sale proceeds thereof will be credited to the account of the purchaser for any claim for sale of the goods at a lower price than the market price and in this respect the purchaser shall be deemed to have appointed the Company as its agent.
- 12.6 Purchaser are cautioned that attempt to misuse Gate Pass, Challans authorizing delivery or any such documents will open them to serious penalties or such other action as may be open to the Company. The purchasers should, therefore, ensure that important documents relating to sale are in the custody of trust worthy and responsible persons.

12.7 For partial lifting forfeiture of balance quantity and proportionate percentage of total ENTRY/ SECURITY/ EARNEST money will be done as mentioned below.

- 12.8 If a buyer fails to lift his materials within the stipulated period as mentioned above, Ground Rent @ 0.1% per day of basic sale amount will be charged from the buyer from the 15th Day of Sale Order till starting date of lifting (both days excluding).
- 12.9 In case of default of deposit within the allowed period, the contract of sale between the purchaser and the Company shall Ipso-fact terminated and the security and earnest money deposited by the purchaser stand forfeited by the Company. The Company shall not be bound to give any notice to the purchaser of the cancellation of the contract of or the forfeiture of the earnest money.
- 12.10 Notwithstanding anything to the contrary contained in various clauses the Company may at any time on the application of the purchaser annul the forfeiture and permit the Purchaser to pay the purchase money with such additional amount and within such period and on such terms and conditions as the company may at its absolute discretion thinks fit.

GST shall be charged as per applicable rates on any recoveries made towards penalty for late payment or ground rent charges.

#### 13. COMPLETION OF SALE ORDER

13.1 A sale order is treated as complete only when the party has lifted the entire lot successfully within the stipulated period depositing all dues.

#### 14. LEGAL

- 14.1 All complaints of whatsoever nature should be referred to the Secretary Scrap Disposal Committee, Tata Motors Limited, Pantnagar immediately by the party / parties concerned. Complaints received by Secretary Scrap Disposal Committee will be referred to SDC (Scrap Disposal Committee, Pantnagar) along with its report / suggestions if any for further decision.
- 14.2 Any decision taken by SDC (Scrap Disposal Committee, Pantnagar) will be forwarded to Plant Head, TML Pantnagar and his decision will be final and binding on the parties. In case of any dispute / disputes arising out of any contract, jurisdiction of District Court Udham Singh Nagar / High Court, Nainital, Uttarakhand shall have exclusive jurisdiction to adjudicate upon any such dispute / disputes.
- 14.3 The Company shall not be liable for non-performance of any contract either wholly or in part nor any delay in performance resulting from or due to any cause beyond the Company's control. Such causes will include fire, strike, go-slow, lock-out, closure, and dispute with workmen, uncertain and unstable labour situation, war, riot, civil commotion, pestilence epidemic, flood, accident, damage or accident to machinery, shortage of wagons, shortage of any raw materials, shortage of labor, Govt. of Railway restrictions, acts/demands or requirements of Govt. force majeure. The causes will also include direct or indirect consequences of the

aforesaid causes. The existence of such causes or consequence shall operate till the time is necessary to enable the Company to effect performance after the causes of delay have ceased to exist. The Company shall be entitled to give notice to purchaser and cancel any contract, the performance of which is likely to be delayed by any of the causes aforesaid. In such cases the purchasers shall have no claim upon the Company of any kind. The provision of this paragraph shall not be limited or abrogated by any other terms of the contract whether printed or written nor will the provisions of this clause abrogate or limit the effect of any other clause mentioned in this catalogue.

- 14.4 The successful bidder shall ensure compliance of all applicable laws and regulations including laws related to Labour, Environment, Health, Safety, Welfare, Social Security, Commercial, and Taxation etc.
- 14.5 The agent, representatives, workers etc. who would be coming inside Tata Motors Pantnagar Plant for inspection of lot, lifting of materials or for any other purpose, shall be covered under ESIC and have valid ESI registration no.
- 14.6 The successful bidder shall ensure that the vehicle which will be coming for lifting of auctioned material, shall be compliant with Motor Vehicles Act and safe for driving on roads.

#### 15. OTHERS

- 15.1 Other terms & conditions shall be announced on the spot at the time of auction/tender.
- 15.2 All scrap Purchaser/their supervisors/labours shall wear PPEs (safety shoes/ Helmet etc.) during scrap lifting and follow the safety norms as advice by the company officer. The purchaser shall ensure the availability of wheel chowks & fire extinguisher before placing the vehicle for scrap loading. In absence of the same the vehicle will not be entered in TML.
- 15.3 TML Pantnagar will not accept any type of concessional sales tax Form i.e. (Form-C or Form-11etc.) against Scrap sale. In GST, there is no such provision of concessional forms, hence all the sale/supply will be charged on full rates.
- 15.4 All quantities and weights mentioned in Annexure-1 are indicative and approximate. No concern/dispute regarding actual availability will be entertained.
- 15.5 With respect to all lots of scrap sold, if the lot's sold qty. exceeds the auction qty. then the buyer/purchaser may be permitted for lifting up to 25% additional qty. over & above the auction qty., on the same terms of payment and lifting. If the qty. exceeds to additional 25%, the lifting of the same may be permitted only after the approval from SDC along with Plant Head in view of the paramount interest of the company to get the area cleared of all accumulated scrap.
- 15.6 If any new customer is introduced in the auction, he will have to provide photocopy of PAN Card, address proof as mentioned in sales tax registration, photocopy of TIN/GISTN registration and bank mandatory form.
- 15.7 For EMD refund or transfer to other location: the purchaser will have to provide a request on his letterhead as well as his account statement.
- 15.8 All the successful purchasers will have to provide the "Undertaking Certificate" regarding ownership of safety of their workers at the time of entry in TML premises, every time or as and when required. The Proforma is enclosed in this booklet.
- 15.9 The purchasers for STA Bids/Lots will not have the right to withdraw their offers until it is rejected by TML. However due to any reason, the purchasers wish to withdraw their offers for Bids/Lots, they will have to deposit the balance amount of EMD (Equivalent to differential of EMD of confirmed bid & EMD of STA bid).
- 15.10 Lifting/loading of scrap material above the truck's body height and in tail gate open condition will not be allowed for any kind of scrap material.
- 15.11 'GST' shall be charged on the sale/supply of scrap materials w.e.f.1st Jul'2017 in addition to the existing taxes wherever it will be applicable. The details of the same is given in Annexure-1.
- 15.12 All the scrap purchaser shall have to provide GSTIN before participation in auction, which is mandatory.
- 15.13 All the scrap purchaser shall have to provide a valid pollution certificate before bidding for the lots, A48U- Plastic, A06EU-Polythene & A06KU-Garbage, which is mandatory.
- 15.14 No subsidy/discount will be given to purchaser in any of scrap lot irrespective of any type of weather condition. Purchaser shall have to lift the material in 'as it is in' condition in order to ground clearance.
- 15.15 Entry of persons / labour brought by the contractors are subject to the compliance of Labour Laws and legal terms & condition (such as ESI & PF) and discretion of the TML authorities.
- 15.16 The contractor shall not bring any person / labour below the prescribed age as per law in force. Persons below the age of 18 years of age brought by the contractors will be declined entry into TML premises unless valid proof of age of the concerned person is provided to their satisfaction.
- 15.17 No person / labour with medical problems of chronic nature viz; epilepsy, impaired eyesight / hearing, sick persons etc., shall be brought by the contractor seeking entry into TML premises.

15.18 If the vehicle is hold, then it will be weighed again the next day, which will be more weight, paper will be made at the higher weight.

#### 16. Good Housekeeping & illumination Clause

#### **Good Housekeeping Clause:**

#### 1. General Cleanliness:

- All areas of the company premises, including workstations, hallways, staircases, and storage areas, must be kept clean, organized, and free of clutter at all times.


